Introduction

New Mexico, the country's fifth largest state in size, is a culturally rich and diverse state with a relatively small population of approximately 2 million, making it the 36th in the nation. New Mexico's population is a diverse blend of predominately Hispanic, Anglo, and Native American population and cultures, with a healthy integration of many other races and communities as well. Most of the population growth occurred in and around Albuquerque and Las Cruces, the state's largest cities and major economic centers.

According to the Census Bureau, approximately 20% of New Mexicans live in poverty, most of whom reside in remote rural locations. The national poverty rate is well below that.

In 2003, New Mexico Legislature authorized a new three-tiered licensure structure tied to a guarantee base pay scale and a statewide teacher evaluation system which is now fully implemented and helping to bring New Mexico up to the middle of the states in teacher salaries.

In August 2012, the NMPED promulgated rules that will align teacher evaluation with rigorous performance measures. This evaluation system will also establish requirements on IHEs to train highly qualified and effective practitioners that meet competencies upon entrance into the teaching profession.

TEACHER SUPPLY AND DEMAND:

The supply and demand picture in New Mexico has improved significantly in the last few years. The number of teachers teaching with substandard licensure, which once reached approximately 10% of the teaching force, has now declined to .0012%.

New Mexico's institutions of higher education (IHEs) have reported an increasing number of completers of alternative licensure programs.

New Mexico officials have sought to learn more about the supply and demand issues in New Mexico, especially in terms of teacher retention. Although data revealed vast differences in retention rates of all teachers as well as beginning teachers among school districts, it has become clear that New Mexico districts with the greatest challenges (i.e., large numbers of students with limited English proficiency, large numbers of students living in poverty, large student drop-out rates, etc.) also have the most difficulty attracting and retaining teachers. There is strong correlation between districts that have a high number of schools rated by the PED as probationary and the retention rate of teachers, the number of first-year teachers, and the number of teachers with an inappropriate license. At the same time, the percentage of waived teachers working in the high poverty district has declined significantly since 2000.

The PED has also supported recent legislation that allows for a streamlined alternative licensure process. Individuals seeking to enter the teaching field will now have an opportunity to obtain level 1 licensure immediately, and within two years meet requirements to elevate to a permanent license.

This new initiative will make it more attractive for highly effective individuals to obtain initial licensure in NM; thus, improving recruitment, and possibly retention.

The PED and its Licensure Bureau have produced, through an exemplary, and consultative process, a well-designed and implemented statewide approach to teacher evaluations and licensure. Currently, the evaluation system utilizes a binary system in which teachers either meet competency or do not meet competency. The evaluation is tied to the continuing licensure of teachers by requiring LEA's to authorize continuing licensure, using a standard form. This occurs every nine years.

TEACHER SUPPLY AND DEMAND:

The supply and demand picture in New Mexico has improved significantly in the last five years. The number of teachers teaching with substandard licensure, which once reached approximately 10% of the teaching force, has now declined to .02212%.

New Mexico's institutions of higher education (IHEs) produced approximately 1,900 teachers during the 2009-2010 school year. This number has grown recently due to an increasing number of completers of alternative licensure programs.

New Mexico officials have sought to learn more about the supply and demand issues in New Mexico, especially in terms of teacher retention. Although data revealed vast differences in retention rates of all teachers as well as beginning teachers among school districts, it became clear that New Mexico districts with the greatest challenges, (i.e., large numbers of students with limited English proficiency, large numbers of students living in poverty, large student drop-out rates, etc.) also have the most difficulty attracting and retaining teachers.

There is a strong correlation between districts that have a high number of schools rated by the PED as probationary and the retention rate of teachers, the number of first-year teachers, and the number of teachers with an inappropriate license. At the same time, the percentage of waived teachers working in the high poverty district has declined significantly since 2000.

TEACHER PREPARATION:

New Mexico is a partner state with the National Council for the Accreditation of Teacher Education (NCATE). As an NCATE partner, New Mexico IHEs that prepare teachers are evaluated based on a combination of NCATE Unit Standards and the New Mexico specialty area (licensure and endorsement) competencies.

Although NCATE accreditation is voluntary, PED program approval is mandatory. New Mexico's seven IHEs that offer standard educator licensure programs currently have full seven-year program approval based on the standards, criteria and procedures established through the joint NCATE/New Mexico partnership.

In the past few years, eight new post-secondary institutions in the state have received approval for teacher preparation programs (mostly in alternative paths).

*Alternative Licensure:

Through the Teacher Quality Enhancement State Grant, New Mexico engaged in a multi-year, multi-faceted project to enhance the state's teaching force. One of the project goals was to attract second career professionals into the teaching profession. As a result, New Mexico adopted an Alternative Licensure Rule that went into effect on July 1, 2000. The alternative rule provides two options for obtaining an alternative license.

Interested persons who already possess at least a baccalaureate degree may either elect to attend a New Mexico IHE that has an approved alternative licensure program or undergo a portfolio assessment whereby their teaching competencies are assessed by a panel of trained educators, or complete a district-based program. In either case, licensure can be obtained in approximately nine months to two years.

The eleven IHEs that have approved alternative licensure programs (including five community colleges) are actively admitting students. The portfolio review process is well established and a district based path is also available. The PED and IHEs are committed to collecting data to determine the success of alternative licensure programs and prepare for any needed revisions to the policies and procedures.

In 1991, the PED entered into a partnership with the Council for the Accreditation of Teacher Education (NCATE) to improve the quality of teacher preparation in New Mexico and to increase the efficiency and effectiveness of the program approval process. NCATE is a voluntary, national professional accrediting agency that determines which colleges and universities meet national standards in preparing teachers. All New Mexico IHEs that prepare teachers are evaluated on the NCATE/New Mexico standards and protocol whether or not they seek NCATE accreditation. The partnership facilitates a flexible evaluation system whereby NCATE unit standards are combined with New Mexico's specialty area program competencies to assess the quality of New Mexico educator preparation programs. For those institutions that choose NCATE accreditation, a joint team comprised of NCATE and state representatives conducts an on-site visit in accordance with the NCATE/New Mexico Protocol. The IHEs that do not choose to be NCATE accredited will be visited by a team consisting of state members only.

The New Mexico Public Education Department has a partnership agreement with NCATE and uses their standards, policies, and procedures as the measure of effective educator preparation programs throughout New Mexico. As part of the state's commitment to a rigorous accountability system for educator preparation programs, all of the Deans of state-funded 4-year programs have agreed to undergo the NCATE national accreditation process. Two year institutions and private schools that prepare educators undergo the review process using the NCATE standards; however, the team that reviews the unit and programs are all New Mexico trained NCATE Board of Examiners.

State standards adopted by the Public Education Department (PED) are used to approve professional education programs which lead to specific licenses and endorsements. The standards are comprised of the PED adopted competencies for all licensure and endorsement programs and are aligned with NCATE's Approved Curriculum Guidelines. The PED requires each institution that has a educator preparation program to undergo a specialty area program review conducted by the Secretary to ensure that all licensure and endorsement programs comply with PED requirements. The Public Education Department has on file the unit's response to the PED competencies for all licensure and endorsement programs.

The PED has the responsibility for determining the requirements and qualifications for licensed New Mexico educators. Since 1989, a competency-based system for preparing and licensing educators has been in place. The main features of this system include:

- A set of PED adopted competencies for each licensure and endorsement area. The competencies reflect the skills, knowledge, and abilities that beginning educators are expected to have upon completion of a New Mexico educator preparation program.
- A specialty area program approval process whereby the PED's Professional Practices Sub-committee reviews the licensure and endorsement programs at each institution of higher education (IHE) in New Mexico to ensure compliance with the PED's licensure regulations and competencies.
- A program approval and national accreditation process by which the entire education unit (college, department, school of education, etc.) at a New

Mexico IHE is evaluated based on New Mexico's competencies and on the national standards of the National Council for the Accreditation of Teacher Education (NCATE).

The Professional Practices sub-committee is a 5 member advisory body to the PED on all policy and regulatory matters relative to educator preparation.

The Professional Practices sub-committee facilitates program approval procedures, serves on visiting teams to evaluate New Mexico's educator preparation programs, evaluates specialty area programs to ensure compliance with the PED's licensure and endorsement requirements, and makes recommendations to the Secretary of Education for changes, additions, or deletions to PED licensure regulations.

The Professional Practices sub-committee of the PPSC conducts the program reviews on a five-year continuum cycle after the first accreditation review. In addition, the Professional Practices sub-committee may recommend to the Secretary whether to participate in probationary, conditional, or provisional reviews.

Institutions wanting to implement new educator programs or make changes to existing approved programs must request a date to meet before the Professional Practices sub-committee and present their program. For new programs, institutions must follow the outlined approval process which includes:

- 1) Description and rationale for program being applied for (e.g. Elementary Education License), with attached applicable PED rule(s);
- 2) If applying institution is a college or a university, evidence that it holds regional accreditation;
- 3) If applicable, explanation of level of credits offered (i.e., lower division, upper division, or graduate) and transferability to undergraduate and/or graduate programs;
- 4) Rationale:
 - a. Need for the program (needs assessment) in the community or region served by the institution
 - b. Supporting data relating to the need for the program
- 5) Assessment data demonstrating evidence of success of currently-approved teacher preparation programs (e.g. Title II Data, Professional Development Dossier Passage Rate for levels I to II);
- 6) Description of the program entry, midpoint, and exit requirements;
- 7) Matrix showing the relationship between PED competencies and the required courses;
- 8) Brief course catalog descriptions for newly-developed and existing courses;
- 9) Course syllabi, each following a uniform format, demonstrating the relationship of the courses to the appropriate competencies (limit 5 pages per syllabi) to include the following:

The IHEs teacher preparation programs prepare general education teachers to teach students with disabilities by bringing together differentiated instructional strategies into required courses. Instructors in the Special Education Program, may sometimes teach courses in the general education program, also address the instructional & IEP (Individual Education Plan) needs of special education learners throughout their courses.

Provide a description of the extent to which teacher preparation programs prepare teachers, including general education and special education teachers, to effectively teach students who are limited English proficient. Since the academic needs and research based instructional strategies for ELL (English Language Learners) and Special Education students are similar, both types of learners are addressed in strategies taught. Strategies, both formal and informal, are discussed to accurately assess student progress toward learning goals in the IEP. The courses present the educator with the ability to effectively apply the strategies in the classroom. Collaboration with regular education teachers is an emphasis in order to support special learners. Curricula is aligned with the State of New Mexico's Content Standards and Benchmarks. Strategies are modeled by the instructor and practiced by the students.

Students learn and apply the elements of reading and the adaptations made for special learners to address skill gaps. Assessments consist of students effectively applying the strategies in lesson plans and classroom activities based on case studies and their individual classroom population (for those who are teaching).

All reading courses in both general education and Alternative Licensure courses address strategies to meet the needs of English Language Learners. These strategies are also included in the Bilingual and TESOL programs offered to prospective teachers as additional licensure programs.

The IHEs prepare special education teachers to teach students with disabilities by providing a firm foundation in pedagogy, content, characteristics of various exception abilities and the relevant classroom strategies to support each one. Students learn to conduct an effective and efficient IEP, per the requirements of the IDEA (Individuals with Disabilities Education Act), as well as develop techniques to train team members in the IEP process. The learning needs of students identified as ELL and receiving special education services are addressed through identifying the specific need of the child, be it communications disorders, perpetual, auditory, and other areas to better target instruction and support in an inclusion program. Students learn to develop and Individualized Educational Plan

The IHEs have identified, "the utilization of technology-based tools to support student learning" as a skill that all teacher candidates will be able to demonstrate by the completion of their program. All teacher candidates create a professional portfolio that evidences their use of technology for teaching and student learning. Many candidates create their portfolio electronically to demonstrate their use of technology for teaching and learning.

The IHEs integrate technology into the curricula and instruction by incorporating the National Education Technology Standards, developed by the International Society for Technology in Education, into their program course syllabi. The programs' matrix evidences the integration of technology into the curricula for teaching and learning.

The Elementary and Secondary Programs require an assessment course, which requires teacher candidates to collect, manage, and analyze data to improve teaching and learning for the purpose of increasing student academic achievement.

The IHEs program's courses provide to teacher candidates a hybrid or web-enhanced format. The hybrid format requires the college faculty and teacher candidates to meet 50% of the time in person and fulfill the remaining course requirements via the Black Board Learning Environment. The hybrid format indicates that the college/university faculty meet 75% of the time face to face but requires 25% of the course requirements via Black Board of other learning environment. These formats require the college faculty and teacher candidates to use technology for teaching and learning environment. This formats require the college/university faculty and teacher candidates to use technology for teaching and learning in dynamic methods, which encourage team building, critical thinking, and provide flexible ways for both parties to communicate and learn.

Assessment of Teacher Competency

Advancement to higher levels of teacher licensure in the State of New Mexico is based on the regulations in Title 6, Chapter 69, of the NM Administrative Code. These regulations outline the competencies for each level and set the parameters for the assessment system. Every teacher will submit a Professional Development Dossier (PDD) at the end of three years of successful teaching at Level I in order to advance to Level II. Teachers who seek Level III licensure may submit an additional PDD after their third year of successful teaching at Level II. The Public Education Department has established guidelines to assist teachers in demonstrating essential competencies for advancement to Level II and Level III, as specified in the regulations.

Level II Licensure

A teacher must apply for Level II licensure at the end of three years of successful teaching at Level I, including successful completion of a formal mentoring program in his or her district. Teachers who have obtained a NM teacher license under interstate reciprocity must have at least two years experience teaching in New Mexico before advancing to Level II. A teacher seeking Level II Licensure must submit a PDD compiled according to the Guidelines.

Level III Licensure

A teacher is eligible to apply for Level III licensure upon completion of at least three years of successful teaching at Level II AND achievement of either an approved post-baccalaureate (master's) degree or advanced certification from the National Board for Professional Teaching Standards. Teachers who have obtained a NM teacher license under interstate reciprocity must have at least two years experience in New Mexico before advancing to Level III.

Application

A teacher applies for both Level II and Level III licensure by completing a Professional Development Dossier (PDD) and submitting it to the designated contractor of the New Mexico Public Education Department.

Submission periods and detailed instructions for submitting the PDD are available from the PDD home page.

The PDD

The Professional Development Dossier (PDD) is a focused, compact collection of documentation compiled by the teacher seeking licensure advancement with support from her/his school district. The PDD documentation is a collection of classroom data (lesson descriptions, handouts, student work, video and audio recordings, photos) with explanations of that data written by the teacher, accompanied by verification and recommendation by the district superintendent. No one part of the PDD serves to fully represent a teacher's work, but the entire PDD is intended to provide evidence to determine when a teacher is qualified to advance to a higher level of licensure.

The PDD is organized into five strands. These five strands are aligned with the NM Teacher Competencies and are designed to help teachers document their teaching for reviewers from outside their school and district. The booklet, Guidelines for the Preparation of the New Mexico Professional Development Dossier, provides detailed instructions for preparing each strand and for submitting a completed PDD. The strands and the documentation required for each are outlined here:

Strand A. Instruction (Competencies I, II and V)

Strand B. Student Learning (Competencies III, IV, VI and VII)

Strand C. Professional Learning (Competencies VIII and IX)

Strands A, B, and C will be represented by data from the teacher's classroom, explained and organized by the teacher to show how he or she meets the competencies.

Strand D. Verification (Strands A, B, and C will be reviewed only when accompanied by this verification.)

For Level I to II: Superintendent verifies: (1) participation in a district's formal mentorship program; (2) three years successful teaching experience at Level I; and (3) that the dossier is accurate and is the work of the teacher.

For Level II to Level III: 1) Superintendent verifies at least three years successful teaching experience at Level II, and (2) that the dossier is accurate and is the work of the teacher.

Strand E. Evaluation (All Competencies)

Superintendent makes recommendation for advancement, based on:

- Quality and completion of the candidate's professional development plan (PDP)
- Verification that measurable objectives were achieved
- Principal's annual observations of the candidate's classroom practice.

Review of Strands A, B, and C

The Instructional (A), Student Learning (B), and Professional Learning (C) Strands will be evaluated by two reviewers from outside a candidate's district. At least one of the external reviewers will have teaching experience in the same or similar subject area and at the same or similar grade level.

Each of these strands will be rated DOES NOT MEET, MEETS, or EXCEEDS the standard for the level to which the teacher has applied. Reviewers will be trained to ensure fair and reliable ratings, and the two reviewers will rate each strand independently. If both reviewers agree on a rating, that will be the final rating. When reviewers disagree, the final ratings will be determined as follows:

- If one reviewer rates a strand MEETS and the other rates the same strand as EXCEEDS, the final rating will be MEETS.
- If one reviewer rates a strand DOES NOT MEET, and the other rates the same strand EXCEEDS, the final rating will be MEETS.
- If one reviewer rates a strand DOES NOT MEET, and the other rates the same strand MEETS, a third independent reviewer will rate the strand.

Licensure Advancement

Licensure advancement is awarded when the following criteria are met:

- Superintendent provides verification for Strand D and recommends licensure advancement for Strand E
- Strands A, B, and C are rated MEETS or EXCEEDS. Licensure advancement will not be awarded if any strand is rated DOES NOT MEET. Applicants for licensure advancement will receive credit for strands rated MEETS and may resubmit any strand rated DOES NOT MEET under conditions established in the rules.

Getting Started

Read all of the Guidelines before you begin. They will help you prepare a dossier that will be easily understood by outside viewers. You may work on and complete the strands in any order, but you will need to carefully organize and order them as instructed in the Guidelines. Because each strand requires some collection of data over different periods of time, it would be helpful to establish a schedule to ensure a timely completion.
